Our Parishioners, many of the residents of Woodford and readers of our Parish Magazine will already know that we have suffered from the theft of capstones from our recently renovated churchyard wall.

The work of repairing this damage has left us with an unbudgeted cost of some £4,000. This is because our insurance cover will only cover the loss and damage caused and not the secure fixing of both the untouched stones and the replacement ones to prevent any further losses.

Furthermore, our Bell Tower has had to have urgent repairs after a structural survey identified several areas needing immediate attention. For obvious reasons, the work was started immediately and has now been completed. These additional expenses have had to be met out of our reserves. However, you may not know that as a Parish we are responsible for the upkeep of the Church through our own management of our finances.



We are not eligible for any grants and we have to organise and control our own funds. Our Parochial Church Council have to manage our assets as wisely as they can, keeping costs to a minimum and protecting our savings wherever possible.

It is on such occasions as these recent events, that our financial plans have needed to be adjusted. We have recently been covering an annual cash deficit of some £20,000 from our reserves, all this being brought about by ever increasing costs, most of which are beyond our control.

The remedial works simply added to this burden and made a large impact on our plans. It is for this reason that we are taking the unusual steps of asking for your assistance in covering the costs of both these repairs. The combined sum is approximately £19,000.

We had an amazing response to last year's "Parish Giving Initiative", and we are more than conscious of the close timing of this additional request. On behalf of the Parochial Church Council we thank you for taking the time to consider this matter and for any financial support you feel you may be able to give.

A Brief Background

As a place of worship, Christ Church is quite unusual in several respects. Notice has been drawn to the fact that the church gives a general impression of being of a 17th Century design rather than 19th Century. It has a Jacobean flavour which could be due to the influence of the architect Edward Blore, who, at that time was remodelling Capesthorpe Hall in a similar style.



In 1841 the church was completed. It was known locally as the “Buttermilk Church” because the labourers were given only buttermilk to drink to assist their labours instead of beer. Seating for the congregation was on simple wooden forms on the stone-flagged floor. There was no gallery or organ loft. There was no decorative timber work or any stained glass. Altogether the church had a very spartan interior. A very slender tower, not capable of housing a conventional belfry is situated on the west gable

The church underwent renovations in 1869/72, and it was at that time that our 18th century Box Pews were installed. It is believed they possibly came from the old Poynton Chapel. The church was enriched by seven stained glass windows and a wealth of carved woodwork and texts.

During the 175 years of its existence many changes have been made to beautify the interior and more recently improvements and extensions have been added to meet the needs of new generations of worshippers. Until 1877, the worshippers were summoned to church by a single bell, which was afterwards transferred to the Day School to perform, no doubt, a similar duty. In June of that year a peal of six bells were installed, but the tower had to be strengthened by the addition of buttresses before they could be placed in position.

At the same time, a chiming clock was fitted to the tower. This was wound up manually twice a week until 2010, when an electric auto-wind system was installed. In 2005 the two clock faces were re-gilded. In 1930 the old bells were taken down, re-cast and two other bells were added. In total, the bells now weigh about 30cwt (1524kg). They are not rung in the traditional way, but struck by hammers operated by steel wires from a keyboard of levers in the base of the tower. Such a set of stationary bells hung in a tower are known as a Carillon.

The effect of weathering of the tower over the past 175 years has seen the locally produced brick deteriorate to the point where it needed a great deal of attention. It is for this reason that our surveyors highlighted this remedial work as a priority.

With this work having been carried out, we are now confident that our landmark carillon bells will be summoning worshippers to church for many years to come.
