3. APPROVAL OF MINUTES OF 23RD OCTOBER 2018 Approved.

4. FINANCIAL UPDATE

- AF stated that the Just Giving website has had only 6 hits; a total of £100 has been donated with £66.97 was received into the bank.
- Two payments of £50 were paid on 22nd July and 21st August.
- Sponsor money has been received by Avro Heritage Museum but the cheque has not been cleared. A letter was sent to Jackson, Barrett and Gass on 17th August, with a follow up letter on 3rd Sept, but they have not yet responded. Green Thumb has not responded to their invoice.
- Currant balance is £1207.89 (which does not include the Avro cheque)

5. MATTERS ARISING FROM THE PREVIOUS MINUTES

1 Constitution; EF sent out the amendments that were discussed prior to the last AGM. Following some discussion, it was agreed that EF would tidy it up and circulate for approval.

9 Amendments to the Constitution

- 9.1Any proposed amendments to the constitution shall be submitted in writing to the Secretary at least three weeks before the date of the next WCC meeting.
- 9.2Such amendments shall be posted on the WCC notice board and circulated to members with the agenda for consideration and discussion at the meeting.

Note we do not have a notice board, and at the moment 'members' are the committee members

9.3Changes to the constitution agreed by WCC shall be put forward for approval at the next AGM.

3 Noticeboard JS contacted Emma Warrington who was getting an updated price. BB advised that the money left with the area committee is now down to around £1000 until next April. JS had already filled part of the application form

Post meeting note; the new price is through SMBC suppliers is £2995 with a further £235 for delivery excluding VAT, and £850 for installation. Though emails it was decided to try and source a notice board as similar ones are available at a quarter the cost but we will have to pay VAT.

7. BRIEF UPDATES

WNF

There was a high turnout (38.6%) for the referendum on Woodford Neighbourhood Plan and 95.8% voting yes. A lot of postal votes were issued and there was a particularly high rate return of these. The AGM is on 2nd October with talks on how SMBC will consider planning applications in Woodford, and updates GMSF and East Cheshire growth village.

GMSF

The result of the responses to the consultation will be available next week; BB will be briefed on Monday. Due to an unresolved wording of the legislation, the plans are progressing as joint plans, where the mayor is not involved. The plans for transport

will be developed from October 2019 to March 2020. It is thought that the examination of the allocations will happen in 2021.

SMBC Local Plan

This is following the GMSF, with consultation in July next year

Liaison with Redrow

Nothing has come from them. They are doing a new film more about Woodford with the church Avro etc. CAE is empty now and both SMBC and Redrow are clear as what is needed for the school, which has to be available when 450 homes are occupied.

8. ANY OTHER BUSINESS

In the WNF the original questionnaire highlighted things there were not planning matters. These have been collated into aspirations for Woodford. One of the aspirations was for integrating the Garden Village with Old Woodford. DR wondered if we could perhaps do a 'fresher's fair' maybe next year at the Community Centre where the new residents can learn about what there is around Woodford and maybe join the committees and clubs. MW agreed to take this idea to the WWMCC committee.

BB stated that the footpath along Chester Road had now been replaced and that kerbs will be put in in front of the houses on Church Lane to protect the grass verges.
