2. SMBC Local Plan

At the request of the councillors this matter was brought forward so they could allow other matters to be discussed after they left.

There is to a be a meeting on Thursday to discuss population and numbers of homes needed. SMBC have an aging population and they have had a response from the government to maybe do it different to what was originally mooted. The clock is ticking, but they are doing better research but there may be compromises as not all greenbelt is good land. Density of building needs to be looked at and SMBC may be able to put the case with a good barrister to progress.

Bredbury industrial estate has been refused but they may appeal.

With regards to Woodford, Harrow has reduced their aspirations, there has not been talk of numbers but could be more like 850 than the original 920. However Harrow are still hoping for further development but not the suggested original 750 but 500. The hangars near to Old Hall Lane have gone and the concrete has been removed but the land may be contaminated.

The idea of moving Queensgate School to Woodford was an idea from the governors, giving them extra pupils. At the moment it is oversubscribed.

Post meeting note this idea of moving Queensgate School to Woodford was defeated. There has already been a start to the new school on site.
