Demolition Commences on the ex-BAE Site

As most Woodford residents will be aware, particularly those living within earshot of the site, demolition commenced in January.

Members of Woodford Community Council and Woodford Neighbourhood Forum met with Stockport Borough Planning Department to discuss, amongst other things, complaints received related to the demolition and the correct procedure for them to be investigated. Regular update meetings have now been set up on site between representatives of Woodford Community Council, Harrow Estates and their contractor Forshaw Demolition and these will continue throughout the project.

A6 to Manchester Airport Relief Road - Exhibitions

Work on the **A6 to Manchester Airport Relief Road (A6MARR)**, formerly known as SEMMMS, is due to start at the end of March 2015.

On 26th January 2015 the Secretary of State for Transport announced the confirmation of the modified Side Road Order and Compulsory Purchase Order (the Orders) for the scheme. Confirmation of the Orders allows the scheme to progress into the construction phase, with the **main construction works set to begin at the end of March 2015**. You may be aware that preparatory works, including environmental mitigation and site clearance, have already commenced in some areas in advance of the start of the main works. Construction of the A6MARR is expected to take two and half years in total, meaning that the road would be open to vehicles in Autumn 2017.

Carillion Morgan Sindall are committed to working with Stockport, Cheshire East and Manchester City Councils to ensure that local communities are kept informed throughout the construction of the scheme. To this end, Carillion Morgan Sindall are holding a series of Start of Works exhibitions where we will provide you with further information about the construction works and how they may affect you.
